Call to Order	The Mayor called the meeting to order at 9:30 a.m.

Approval of Agenda	Motion by Councillor Arsenault that the agenda for today’s meeting be approved with the above additions. CARRIED
Approval of Minutes	Motion by Councillor Kelleher-Empey that the minutes of the March 25 th , 2014 meeting be approved as presented.
Presentation TJ Brand Refresh Initiative Business Arising	Council received a PowerPoint presentation from Philip Coppard and Charlie Easton of Stormy Lake Consulting, and Mary Darling on the Brand Refresh Initiative for Tourism Jasper. A copy of the PowerPoint presentation is attached to these original minutes. The CAO indicated he had had a brief conversation with Cathy Jenkins on what impact any community development outside the community would have if the Maligne Lake project is approved. Ms. Jenkins advised that part of the proposal suggests there would be staff accommodation inside the Municipality.
Brief Updates Summer Camps	Yvonne McNabb reported that she will be having a meeting on April 14 th with the Elementary School principal to discuss summer camp accommodation. Mrs. McNabb advised that there is a possibility that we will have four more rooms and we do have the gym at our disposal.
Planning Review	CAO provided a draft MOU which sets out the context and atmosphere as to how the review of the agreement to establish local government will be conducted. Discussion centred on costs, tender format, and time frame. Mayor Ireland would like a statement committing us in general terms, outlining our own process. This item will appear on the April 15 th regular meeting agenda.
Jasper Rodeo	RFD for decision on April 15 th regular meeting agenda. It was noted that the Rodeo is a member of the Chamber. Chamber has cancelled its yearly Jeanz and Beanz event this

year. Chamber would like to see dates of rodeo changed to June. Rodeo has not approached the Chamber for assistance this year. In response to a question from the Mayor regarding cost savings which might accrue to the Municipality if there was a change in the dates, Mrs. McNabb responded that the ice would be put in in August, and this would eliminate one complete install of ice if dates were changed. A saving of about \$8,000. \$2,000 alone would be start-up costs. Tourism Jasper would prefer that the Rodeo be held in June. Mrs. McNabb believes that, without the Rodeo, the Municipality would do full cleaning once every ten years.

- TCYHA The TransCanada Yellowhead Highway Association conference is being held in Valemount from May 15th to 17th. Councillor Kelleher-Empey and Councillor Damota wish to attend this conference. This item will be on the April 15th agenda for waiver of public notice and decision.
- 2017 Seniors Games Council received information from Hinton on the 2017 Seniors Games. Hinton is asking if the Municipality of Jasper would like to take part. Deadline for bids is April 30th. Previous games have realized legacies over the years; these events contribute well to tourism. The games would be held in February 2017. A letter of intent to be sent by Hinton, indicating Hinton and Jasper's interest. Mrs. McNabb to contact Marmot Basin regarding games requirements.
- Library CAO reported on the library renovations progress with no date yet set for completion. Mr. Waterworth indicated that there are three major issues still to be dealt with- stairs, fire screen, and vestibule doors, plus some other minor issues.
- FCM Deputy Mayor Nesbitt indicated his interest in attending the upcoming FCM convention and, specifically, the workshops being held on rail safety.
- Daycare staffing in camera Motion by Deputy Mayor Nesbitt that, in order to discuss a matter concerning a staff and client issue at the daycare, Council move in camera at 10:50 a.m. CARRIED
