Business Arising In response to a question from Councillor Nesbitt, Mr. Fercho indicated that the office closure pilot was well received by staff, as it allowed them to take time off over the holidays. Feedback from users will be gathered in the new year to determine what impact the closures had on them.

Councillor Damota received positive comments following the publication of the library project schedule, and commended Mr. Fercho for his work on the project.

Brief Updates

Councillors discussed their role as Council representatives on various boards and committees. Mayor Ireland encouraged Councillors to bring forward topics of interest to committee meetings for discussion, as required. Councillors agreed to forward known committee and board meeting dates to Mrs. Cahill for inclusion in a calendar of

upcoming board and committee meetings.

MoU Jasper Dispatch Chief Van Tighem presented the Memorandum of Understanding for review and discussion. Council will be requested to formally approve the document at the January 6 regular meeting. Mayor Ireland suggested that Administration review the bylaws and policies outlining signing authorities for the Municipality and bring them forward for review and discussion at an upcoming Committee-of-the-Whole meeting.

Recess

Mayor Ireland called a recess from 10:19 to 10:27 a.m.

Fire Truck Purchase Fire Chief Van Tighem presented background information on how the Fire Department acquired assets in the past and the current need to replace Engine 2, as planned through the department's capital asset replacement schedule. Funds for purchasing a

new truck are in reserves, and some funding from Improvement District 12 is available. It is imperative that the Municipality of Jasper purchase a new truck to maintain safety standards for community fire protection and for the safety of our firefighters. A request for decision will be brought to Council at the January 20, 2015 meeting.

Museum and Library Funding Councillor Arsenault sought clarifications on the Municipality's funding and support obligations towards the library and the museum. Municipal Council has the authority to create a Library Board through a municipal bylaw, and has the ability to control, in part or in whole, the operating budget prepared by the board. While Council has no such authority in the museum's operations, it does have an obligation, along with Parks Canada, to preserve the integrity of the archives.

Over the years, Council has requested business and sustainability plans from the museum to ensure municipal funding was used towards a sustainable future for the organization. Council has not received any formal request or presentation from museum representatives for the 2015 budget cycle.

Budget

Councillor Nesbitt finds receiving the capital and operating budgets together beneficial, allowing for opportunities to review which sources of funding are used for what purpose, and explore possibilities for funding reallocations. Mayor Ireland suggested that Councillors start drafting motions for any changes to specific items in the operating budget, which Council will approve, reject or amend at the January 6 regular meeting.

Maligne Valley Access Restriction Councillor Wacko expressed concerns with the tardiness of the access restrictions announcement. Council discussed the representation of municipal interests in the backgrounder document distributed with the announcement.

Mountain Pine Beetle Council received, for information, a letter from West Fraser Mills on the Mountain Pine Beetle Epidemic.

In Camera Session Council moved to an in-camera session at 12:05 a.m.

Council reverted to an open meeting at 12:16 pm

Let's rodeo ...!

The Jasper Heritage Rodeo Association is now planning our 23rd annual professional rodeo in August of 2015. This year, it will be a new outdoor venue. We are presently working with Parks Canada to select an optimum site from their perspective and from ours. The policies of both the Canadian National Parks and the Canadian Professional Rodeo Association will be respected. It is our responsibility to uphold these standards as we move to an outdoor venue.

The sport of rodeo grew out of routine practices in the working cowboy's day. In Jasper National Park, it also derives from the pack-horse trains which opened the west during early exploration and the fur trade era, the survey parties for the routing of railways across western Canada, early ventures of outfitters, mountain climbers, surveyors, geologists, biologists and the first tourists into the Rocky Mountains, until today, it is recognized as a national sport.

Rodeo first came to Jasper in 1925 as an informal competition among horse handlers, established by the Jasper Horseman's Association and held at Henry House Flats. It was continued under the auspices of the Jasper Rodeo and Turf Club, founded in 1929, and held outdoors at what is now Whistler Campground (Marmot Meadows) from 1929-1968, starting under the direction of Sir Henry Thornton, then President of Canadian National Railways, followed by Jack Brewster, Ed Neighbour and Gene Merrill, all outfitters by trade. All contestants were amateurs and members of the Foothills Cowboy Association. Post-war reorganization was assisted by a grant in 1951 from the Canadian Federal Government. At this time, the Jasper Rodeo included many non-professional events such as cow-milking, mutton-busting, pole-bending and pony chuckwagon races. The Jasper Curling Club took over in 1977 and moved the rodeo indoors in 1978. The Jasper Lions Club became involved in 1985, and in 1991 the rodeo turned professional and joined the Canadian Professional Rodeo Circuit.

Funds raised by the rodeo, the only rodeo to be held in a National Park, were redistributed within the community. The present Jasper Heritage Rodeo Committee, comprised entirely of volunteers, seeks to continue this tradition while, at the same time, providing insight into the history and policies of Jasper National Park through entertainment of the many international tourists who visit Jasper each year.

We would like to invite you to contribute to this educational opportunity through your sponsorship of the Jasper Heritage Rodeo. Advertising throughout rodeo week (website links, media announcements and coverage, posters, program acknowledgments, arena banners and flags, etc.) extends exposure of your business not only within Jasper but also to surrounding areas and internationally. Financial contributions are tax-deductible since the Jasper Heritage Rodeo Association is a registered non-profit organization certified in 2002 by the Province of Alberta. All monies will be held in trust until a suitable venue is identified. Gifts-in-kind are recognized through advertising. Any profits are redistributed through community grants to such organizations as Community Outreach, Jasper Assisted Living, HIV Yellowhead and Therapeutic Riding (Advocates for Special Kids). Many other community non-profit organizations, such as the Jasper Volunteer Firefighters, MS Society, Right To Read and Cancer Support Group, are able to raise funds through contracts with the rodeo to perform such services as security, concession sales and clean-up.
