**ECC Update** 

The Director of Emergency Management, Greg Van Tighem, reiterated the ECC is virtually operating under a partial activation; municipal staff currently involved in the ECC are doing so on a part-time basis, and continue to perform their regular

duties.

Emergency Social Services (ESS), a branch under the municipal ECC, continues to focus on the social impact of the pandemic on the community through numerous

programs.

The ECC will continue updating its objectives as warranted. A new objective is to

provide weekly ECC updates to the public.

The ECC and other community partners, such as Parks Canada, RCMP and Tourism Jasper, are working together to remind visitors now is not the time to visit Jasper.

Councillors asked clarifying questions and requested that an ESS activity report be presented at the next meeting.

Tourism Jasper presentation

Tourism Jasper provided a visitor economy update, highlighting the drop in tourism and what to expect moving forward. General Manager James Jackson also said Tourism Jasper ceased all promotional activity several weeks ago. The organization is encouraging visitors to stay home.

Recess Mayor Ireland called a recess from 10:45 am until 11:00 am.

Bylaw Summary Council received a list of bylaws currently in force and those in various stages of readings.

Economic Recovery Task Force Terms of Reference Council and Administration are still drafting terms of reference for the COVID-19 Economic Recovery Task Force. This item will return for further discussion and consideration at the next Council meeting.

COVID-19 Budget Reductions and Required Service Reductions The newly established Budget Review Committee has met several times to discuss service cuts required to decrease the municipal budget by \$982,000.

This agenda item was deferred until the next Council meeting, where the committee is scheduled to present its recommendations.

Council received notice from the Government of Alberta regarding several provincial deadline extensions. Of note for the residents of Jasper is the property assessment appeal deadline, which has been extended until July 1.
